Broadway Cuts Phosphorus by 85%

Shenandoah Riverkeeper and Potomac Riverkeeper Actions Force Facility Upgrades

Shenandoah Riverkeeper Jeff Kelble and Potomac Riverkeeper Ed Merrifield have had their eye on the North Fork Modular Reclamation and Reuse Facility—a wastewater treatment facility—since August 2006, when it was owned by SIL International, LLC. SIL had violated its clean water permits by almost 14,000 pounds of

nitrates and by 48,000 pounds of phosphorus in a single year.

The Township of Broadway, VA took over the facility in 2007, after Ed and Jeff had started legal actions against SIL. Bringing the plant into compliance would remove 62,000 lbs. of pollution from the Shenandoah River annually, and Ed and Jeff wanted to make that happen.

Thanks to our Riverkeepers' efforts, the plant's owners have cut phosphorus emissions by almost 85% since taking over. There is more work to do, including upgrades to the facility, before the plant complies with the permits that SIL violated, but this is a big step in the right direction.



End Near in Two Year Battle with Merck Shenandoah Riverkeeper Argues Proposed Caps Should Not Be Increased

Shenandoah Riverkeeper Jeff Kelble applauded Virginia's Water Control Board for deferring action on a request by the Merck Pharmaceuticals plant in Elkton, Virginia at its meeting on December 4.

Merck wanted to increase the amount of nutrient pollution it would be allowed to discharge into the South Fork of the Shenandoah River when Virginia's rules for pollution reductions to protect the Chesapeake Bay take effect in 2011. Merck had petitioned for a nitrogen pollution cap increase of roughly 30,000 lbs. (a 300% increase) and a phosphorus pollution cap increase of roughly 3,000 lbs. (a 400% increase).

Jeff has led the fight against Merck's petition since we discovered its filing nearly two years ago. Shenandoah Riverkeeper argued at the Control Board meeting that Virginia cannot adopt Merck's suggested cap increases because they would prevent achieving the 2011 water quality standards.

The nutrient caps were created so that Virginia can honor its commitment to the Chesapeake 2000 Agreement. One major problem is that Virginia has already over-allocated its pollution levels in the Shenandoah and Potomac.

Increasing Merck's cap would require finding pollution reductions elsewhere in order to meet the pollution reduction targets set by Virginia to restore the Bay. The good news is that no matter where the Board sets the cap in March, Merck will have to greatly reduce their current nutrient pollution discharge.



Riverkeeper Visits Morgantown Power Plant November 21, 2008

Potomac Riverkeeper Ed Merrifield and his attorneys toured Mirant's power plant in Morgantown, Maryland, at the invitation of Mirant.

PRK has been tracking the plant for some time, and is interested in making sure the coal and its by-products not end up in the water.

Ed is standing in a tube that is 1/4 of a mile long. The tunnel keeps coal and its by-products away from the water while it is being transported from the barge to the plant.

This transport system is one of two being used in America.

PRK Submits FOIAs Wants to Know What's in Our Water

The safety of our drinking water depends on the health of our rivers and streams. The effects of contaminated drinking water can be devistating, which is why it is so important that we know exactly what is in it!

Potomac Riverkeeper recently submitted Freedom of Information Act (FOIA) requests to four area water suppliers, asking for:

- Testing data for the last three years on the presence of chemicals, pollutants, pharmaceuticals
- Testing protocols that have been proposed, adopted and/or implemented in the last three years for the presence of chemicals, pollutants, and any other compounds

This information is clearly in the public interest, and Potomac Riverkeeper wants everybody in the community to know what's in their water, and what the water providers are doing about it.

Shortly after our requests were sent, the U.S. Geological Survey released a study that revealed our water has small amounts of herbicides, gasoline additives and industrial solvents.

The USGS measured water from the Washington Aqueduct, and found 17 chemical compounds that had escaped the treatment process.

The study says that the chemicals are only detected in trace amounts and most likely do not negatively impact human life, but impact of sustained ingestion has not been studied, and one of the chemicals may possibly be at the root of the intersex fish issue.

Potomac Riverkeeper is committed to pressing water companies to disclose what they know about our water, both before and after it enters their system, so we can make sure that we have safe drinking water. 


