I would like to formally submit a complaint about excessive algae blooms in the South Fork Shenandoah River in Warren County. The photos in the addendum below, taken 7/21/18, show just a few examples of the heavy algae coverage on the bottom of the river in many areas between the Hazard Mill Boat Landing, on Rt. 629, and the Bentonville Boat Landing, at the bridge on Rt. 613 in Warren County. These locations are probably not visible from public roads. This is a very popular recreational section of river and the algae blooms can be discouraging to boaters, tubers, swimmers and fishermen. On 7/21/18 when these photos were taken, Shenandoah Riverkeeper and the U.S. Forest Service were leading a river snorkeling trip on this section of river. Many of our snorkeling guests complained about the thick blanket of algae that was on the river bottom and floating by. The algae strings were clinging to our feet and hands as we explored the river below the surface. The top matts of algae had a foul smell.





The photos in the addendum below, taken 8/29/18, show just a few examples of the heavy algae coverage on the bottom of the river in several areas between Crimora and Harriston. These locations are not visible from public roads. The algae blooms near Crimora did not have as many green patches as the ones closer to Harriston. The farther I boated, the worse (with thicker coverage) the blanket of green algae became.
